On June 3, 2019, AMFA and Alaska Airlines (AS) announced an Agreement in Principle (AIP) on another Transition Agreement to integrate the Legacy Virgin America (Airbus) Technicians into our current collective bargaining agreement with Alaska Airlines. The AMFA Committee is working with the Company to finalize the documents and we should have them ready to send to you in the coming week. The full Transition Agreement with an updated Article 26 Schedule A Pay Scale, which will reflect what is in the Transition Agreement along with Seniority Agreement, will be emailed to each member’s Alaska email for review.
