The AMFA-Alaska Negotiating Committee (the "Committee") is providing this update to the Membership at Alaska Airlines (AS). This is the only official authorized source of negotiating communications by the Committee.

The parties held a four-day bargaining session September 5-8 in Renton, WA to continue bargaining toward a successor collective bargaining agreement (CBA).

The parties bargained long hours each day, and on September 8, AMFA and Alaska Airlines reached an Agreement in Principle (AIP) on amendments to the current CBA. The AMFA Committee is working with the Company to finalize the language on the agreement, and we should have the document ready to be sent out to you shortly. The full agreement will be emailed to each member's Alaska email for review, and it will be posted on the Alaska Maintenance & Engineering website under the AMFA tab.
