## **Nomination Process**

- **Deadline:** All nominations must be received by **May 21, 2026, at 1700 hours (5:00 PM PDT)**.

## **Eligibility**

All members in good standing assigned to Local 32 are eligible to nominate. Candidates must meet the eligibility requirements of Article XIX, Section 1(B) of the AMFA Constitution.

## **Elections**

### **Neighbor Islands Area Representative**

An election will be conducted if more than two (2) valid nominations are received. This individual serves as the Area Representative for the designated stations, facilitating communication between the ALR and the Shop Representatives.

### **Shop Representatives**

The number of positions filled will be determined by the ASA ALR based on the specific needs of each location. If the number of valid nominations exceeds the required amount for a station, an election will be held.
